

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .TRAVEL domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

Section .TRAVEL.1. Trustee authority and Registry

.TRAVEL is an ICANN generic Top-Level-Domain (gTLD) dedicated to the travel and tourism industry. The following diagram presents the various parties involved and the Trustee Authority for the .TRAVEL TLD:

Section .TRAVEL.2. Registration terms and conditions

When You apply to register a .TRAVEL domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .TRAVEL domain names, as defined by ICANN and Tralliance, and which may be viewed at the following pages:

Eligibility

.TRAVEL domain names are restricted to persons who are significant participants in the travel and tourism industry:

Registry Policies (1. Eligibility)

Before applying for a .TRAVEL domain name registration via Our website, You must obtain a Unique Identification Number (UIN) which is a reference indicating that You have submitted Your authentication information to the Registry

The authentication procedure is carried out by the Registry with the support of industry associations or independent authentication organizations ("Authentication Providers") listed at the following address:

If You do not already have a "UIN", You must:

- if You are a member of one of these associations, please go to | ICANN reserved names: its website and complete the authentication procedure,
- · if you are not a member of any of the listed associations, You may authenticate through the Tralliance Authentication Provider (TRAP) by fill out the Registry authentication form.

Once Your authentication application has been sent (Privacy Policy), You will receive Your "UIN" which You will then need to add to Your registration request on Our web site.

Please note that Your "UIN" does not mean that You have successfully accomplished the authentication process as long as the Registry have not checked Your eligibility. During the verification, the Registry may request additional documents from You. Once Your eligibility has been approved, the Registry will inform You of this by email.

If the Registry considers that You are not eligible for the registration of a .TRAVEL domain name, You will be granted a deadline of 30 days to appeal this decision by one of the following procedures (Registry Policies 5. Dispute resolution and denial review):

Your "UIN", once approved, confirms Your eligibility for the registration of a .TRAVEL domain name for up to one year. The Registry will review Your eligibility status annually, or at any other time, to ensure that Your authentication data has not changed.

It is therefore necessary that You keep Your contact information up to date, by informing the Registry of any changes (http://www.travel.travel/index.php/contact-us). Your eligibility may then be examined by the Registry.

If during the registration period of Your .TRAVEL domain name, the Registry obtains information that demonstrates that in reality You are not eligible or if You are no longer eligible, the Registry will delete Your domain name without compensation or refund.

Use of Your domain name

Within one year following the date of registration and thereafter throughout the term of the domain name, Your domain name must be used for a website displaying travel content, or used in a similar manner (such as email). The registry carries out verifications, and failing this, will give You a deadline of 60 days to correct this before it will delete Your domain name.

Domain name choice

The rules governing the domain name choice are available at the following address: Registry Policies (2. Names Selection).

The owner of a .TRAVEL domain name is not entitled to sell or allocate third level names under his domain name (ex: aaa.mondomaine.travel) to entities that are not owned or controlled by him.

Registration period

The registration term is from 1 to 10 years. To avoid any deactivation or deletion of the domain name, the renewal must be paid and funds cleared before the Expiration date.

Your liability

You agree:

- to provide and maintain accurate, reliable and up-to-date personal contact information,
- · that Your .TRAVEL domain name and its use are in the best interests of the community of the travel and tourism industry.

Failing this, the .TRAVEL Registry can delete Your domain name.

Section .TRAVEL.5. Storage of contact information

In application of ICANN contracts, all personal and technical information associated with the registration of Your domain name is recorded and made available to ICANN and IRON MOUNTAIN (ICANN's designated Registrar Data Escrow agent), in addition to messages pertaining to each registration or modification, during the entire duration of the registration of the domain name, plus the three following years.

You accept that the ICANN and the .TRAVEL Registry can access Your personal contact information and display it in the public Whois database.

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status,
- does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration),
- · was created at least 60 days prior to the request,
- the last transfer is older than 60 days.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

Section .TRAVEL.8. Ownership change

Before requesting an owner change, the new owner must have a "UIN" (see Section 3 Eligibility).

The owner change can be done through a fax-based process (Gandi form and proofs of identity). The former and the new owner shall have to also inform the Registry of the owner change: http://www.travel.travel/index.php/contact-us

Any owner change will result in a one-year extension of the current domain name registration period.

Section .TRAVEL.9. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at the normal price is possible during this period.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.

Section .TRAVEL.10. Your obligation of guarantee

In any case, You commit Yourself to indemnify, defend and hold harmless the .TRAVEL Registry, the Registry Operator and their subsidiaries, affiliates, divisions, shareholders, directors, officers, employees, accountants, attorneys, insurers, agents, predecessors, successors and assigns, from any and all claims, demands, losses, costs, expenses, causes of action or other liabilities of any kind, whether known or unknown, in any way arising out of, relating to, or otherwise in connection with Your domain name registration. This guarantee shall prevail after the end of the present contract, whatever may be the cause, and is the direct consequence of Our accreditation agreement with the Registry.

Section .TRAVEL.11. Third party beneficiary of this contract

The .TRAVEL Registry is and shall be an intended third party beneficiary rigin beneficiary of this contract, and the parties to this contract accreditation agreement.

acknowledge and agree that the third party beneficiary rights of the Registry have vested and that the Registry has relied on its third party beneficiary rights under this contract, and pursuant Our accreditation agreement.
