

## ANNEX .PRO – SPECIAL CONDITIONS FOR THE .PRO TLD

version 2.0 of 8 September, 2008

In addition to Gandi's [General Terms and Conditions](#) of Domain Name Registration, the registration and use of a .PRO domain name implies the acceptance of and compliance to the present special conditions.

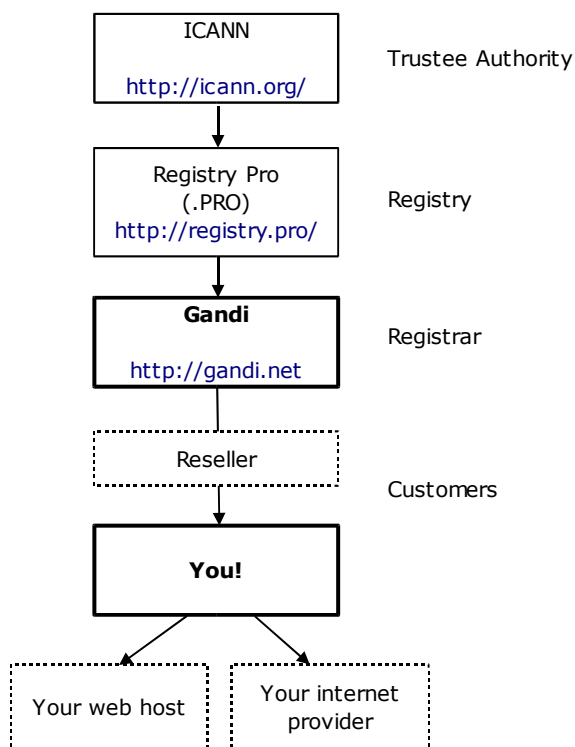
All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at <http://www.gandi.net/admin/contracts/>.

### Section .PRO.1. Dates

The .PRO is an ICANN top level domain. Previously restricted to registrants in the accounting, engineering, legal and medical fields, it is available to all licensed and credentialed professionals and professional entities internationally, since Monday, September 8, 2008 (Live Start date announced on the Registry website <http://registrypro.pro>).

### Section .PRO.2. Trustee Authority and Registry

The following diagram presents the various parties involved and the Trustee Authority for the .PRO TLD. You can view the information and special rules of each party involved by clicking on the respective links.



### Section .PRO.3. Registration terms and conditions

When You apply to register a .PRO domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .PRO domain names, as defined by Registry Pro, which may be viewed at the following addresses:

### Section .PRO.4. Special requirements

.PRO special conditions are available at: <http://www.gandi.net/domain/pro/info>.

.PRO domain names are restricted to qualified professionals: licensed and credentialed professionals and professional entities.

The minimum registration duration is two years.

Gandi provides **.Pro Second-Level Resolving** domain names to qualified registrants if:

- You are a person or entity who provides professional services, and
- You have been admitted to or licensed by a government certification body, or jurisdictional licensing entity recognized by a governmental body, and
- That body or licensing entity requires that its members be licensed or admitted to provide services, and
- You are in good standing.

If You fail to comply with these .PRO requirements, the domain name can be deactivated and/or deleted.

You must be able to provide, immediately upon our initial request and without delay, evidence of qualification for a domain name in the .PRO TLD, that is to say:

- Your Name
- Your Profession
- Your Jurisdictional Country
- Your Licensing Authority
- Your License Number
- A link to your Licensing Authority's website.

You also may be required to provide additional information to the Registry in order to activate or retain Your domain.

Registry Pro will monitor new and renewed .Pro domains to ensure compliance with all applicable terms and conditions. You represent and warrant that You meet the applicable .PRO registration requirements within the Jurisdiction, and agree that, during the term of the registration, You will continue to meet such requirements, and that You will promptly notify Us if You no longer meet

such requirements.

**Failure to provide the requested information** or documents within the time limit (60 days for a new registration; 44 days for an existing domain name) **will be a basis for domain name cancellation**, without penalty or refund.

Gandi and/or Registry Pro shall have the right to, immediately and without notice to You, suspend, cancel or modify Your registration if, at any time, You fail to meet the registration requirements for a domain name.

All two-character and three-character labels are reserved, as well as the ICANN reserved names:

**Gandi does not provide RegistryPro digital certificates**, third-level Professions-Specific domains (such as yourcompany.med.pro), .Pro Defensive registrations, or Sunrise products.

Once the domain registered, You can not modify contacts or DNS within 120 days.

### **Section .PRO.7. Transfer**

Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a Transfer Prohibited status
- does not expire soon (We recommend that You start the transfer request at least one month before the domain's expiration)
- was created at least 60 days prior to the request, or renewed/transferred at least 7 days prior to the request.

Upon successfully transferring the domain, it is automatically renewed for an additional year.

### **Section .PRO.8. Deletion process**

Late renewal is possible at normal renewal prices up to 30 days following the Expiration date.

After this period, the domain name goes into Registry HOLD Period, for 14 days. It can still be renewed.

If the domain is not renewed within these deadlines, the Registry will delete the domain name.
